This appliance must be installed, commissioned and serviced by a qualified person in accordance with national and local regulations in force in the country of installation.

If the supply cord is damaged, it must be replaced by the manufacturer, its service agent or similarly qualified person.

Ensure that the plug/socket is accessible at all times.

Strip plastic coating, fit the feet and clean the appliance before use.

During operation parts may become hot - avoid accidental contact.

Disconnect this appliance before servicing, maintenance or cleaning.

INSTALLATION AND COMMISSIONING

This appliance must be earthed.

If replacing the plug connect the terminals as follows:

Green and Yellow wire Earth E
Blue wire Neutral N
Brown wire Live L

Supply cords shall be oil resistant, sheathed flexible cable not lighter than ordinary polychloroprene or equivalent elastomer sheathed cord (code 60245 IEC 57)

The rubber feet **must** be fitted into the base holes provided. This is to provide ventilation to components.

Install this appliance on a level surface ensuring all vents are unobstructed. Any partitions, walls or furniture must be of non-combustible material. Minimum distances A 100mm B 1000mm – see Fig 1.



Instructions for fixing to wall brackets are provided with the brackets. Dirty extraction filters and drip trays may become a fire hazard due to a build-up of grease/fat and also drip down onto equipment below. Regular cleaning of extraction filters and drip trays MUST be carried out and it's the installer's responsibility to make the operator aware of this.

If the unit is installed above or adjacent to a heat source, the maximum temperature surrounding the unit must be no greater than 50°C. The installer will need to use an insulated shelf and install heat shields to protect the unit as required.



Consulting Fig 2, connect the appliance to an electrical supply – the green neon illuminates to indicate power to the appliance.

The timer must first be set for either appliance to heat up. Set the timer (A or D) for a required time, the elements will switch off when the time expires. For constant heat turn the timer knob fully clockwise to the 'H' (Hold) position.

LPC – the upper elements are on constantly, the lower elements are controlled by C.

LSC – control of the upper and lower elements is independent by F and I.

The amber neons indicate the cycling of the elements.

CLEANING



Do not use a water jet or steam cleaner, and do not immerse this appliance.

Clean all panels with warm water and mild detergent, do not use abrasive materials. Dry with a soft cloth.

SERVICING, MAINTENANCE AND COMPONENT REPLACEMENT



To replace a glass element (Fig 3) remove toast rack, grill pan and reflector.

The elements are sprung loaded. Carefully push the element sideways (1) until the end is clear of the ceramic ferrule.

Ease the element down through the cut out in the side bracket (2) and remove.

Reverse the procedure to replace the element. Be aware that the elements are fragile and damage easily.

All other servicing, maintenance and component replacement on this appliance should be carried out by one of our recommended service engineers.
